The final portion of the trail was completed along the Nokiidaa Trail system linking more than 20 kilometres of trail from East Gwillimbury through to Aurora. lifestyle, reduces vehicle emissions by encouraging walking and cycling and brings the community together to enjoy the great outdoors.

Invasive plants: What are they?

Invasive plants are non-native species that outcompete native plants for resources and space. They may directly kill native plants, introduce disease, and/or hybridize with other plant species. Invasive plants typically prefer disturbed habitats, are aggressive, have high reproductive rates, are transported easily, and lack natural predators.



Impacts of invasive plants

- Outcompete native species (such as white trilliums), and affect forest regeneration reducing wildlife populations that rely on them.
- Can be poisonous to people, causing rashes or burns.
- Impede property access and increase trail maintenance.
- Cause expensive repairs to houses and infrastructure

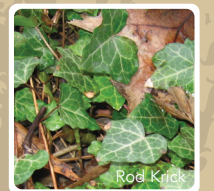


